AMENDED NOTICE OF WORKSHOP DOCKET NO. 2015-362-E

Joint Application of Duke Energy Carolinas, LLC, Duke Energy Progress, LLC and South Carolina Electric & Gas Company for Approval of the Revised South Carolina Interconnection Standard.

On April 26, 2016, the Public Service Commission of South Carolina (the Commission) issued its Order Adopting Interconnection Standard and Supplemental Provisions (Order No. 2016-191). The South Carolina Generator Interconnection Procedures, Forms, and Agreements for State-Jurisdictional Interconnections is attached as Order Exhibit 1 to Order No. 2016-191. During its Regularly Scheduled Meeting on September 14, 2016, and pursuant to Commission Order No. 2016-658, the Commission ordered its Staff to schedule a Workshop.

PLEASE TAKE NOTICE THAT PURSUANT TO 10 S.C. CODE ANN. REGS. 103-817 AND COMMISSION ORDER NO. 2016-658, THE PUBLIC SERVICE COMMISSION OF SOUTH CAROLINA WILL CONDUCT A WORKSHOP REGARDING THE EFFECT OF THE INTERCONNECTION STANDARD IN COMPLYING WITH THE DISTRIBUTED ENERGY RESOURCES ACT IN DOCKET NO. 2015-362-E ON THURSDAY, DECEMBER 15, 2016, AT 10:30 A.M. IN THE COMMISSION'S HEARING ROOM, SYNERGY BUSINESS PARK, 101 EXECUTIVE CENTER DRIVE, COLUMBIA, SOUTH CAROLINA.

DURING THE WORKSHOP, PARTIES MUST REPORT ON THEIR PROGRESS IN MEETING THE REQUIREMENTS OF THE SOUTH CAROLINA DISTRIBUTED ENERGY RESOURCE ACT. FOR EXAMPLE, SUCH PROGRESS REPORTS SHOULD INCLUDE UPDATES ON THE BACKLOG OF INTERCONNECTION STUDIES AND THE AMOUNT OF SMALL RESIDENTIAL INSTALLATIONS.

PARTIES MUST FILE WITH THE COMMISSION AND SERVE OTHER PARTIES WITH DIRECT STATEMENTS ON OR BEFORE NOVEMBER 7, 2016. ADDITIONALLY, IF PARTIES DESIRE TO FILE RESPONSIVE STATEMENTS, SUCH PARTIES MUST FILE THESE STATEMENTS WITH THE COMMISSION AND SERVE OTHER PARTIES ON OR BEFORE NOVEMBER 26, 2016.
