
BellSouth Long Distance Inc. d/b/a AT&T Long Distance Service (“AT&T Long Distance Service”) respectfully submits its notice that it elects to have its rates, terms, and conditions for its local exchange services determined pursuant to the plan describe in S.C. Code Ann. §58-9-576(C). As the Public Service Commission of South Carolina (“the Commission”) has approved a local interconnection agreement in which AT&T Long Distance Service is a participant with an unaffiliated entity,¹ AT&T Long Distance Service “complies with subsection (A)(1)” and, therefore, is entitled to make this election.² Accordingly, this election becomes effective by operation of law thirty days after this notice is filed with the Commission.³

¹ A copy of the Interconnection Agreement between AT&T Long Distance Service and Alltel South Carolina, Inc. is on file with the Commission and is available for viewing on the Commission’s website under Docket No. 2005-228-C. This agreement is deemed approved by the Commission by operation of 47 U.S.C. §252(e)(4).
