COMMISSION ACTION:

As directed by Commission Order No. 2020-570, Duke Energy Progress, LLC and Duke Energy Carolinas, LLC have submitted proposed procedural schedules for the Solar Choice Tariff Proceedings. Having reviewed their comments, I move that we find that their proposals should be modified due to a conflict with another hearing in early January 2021. Therefore, I move that the suggested date for the Joint DEC/DEP Evidentiary Hearing begin on January 20th rather than January 11th and that the date for proposed orders be changed to February 5th rather than February 3rd 2021. I further move that the Commission approve the following schedule:

DEC and DEP Applications & Direct Testimony due November 2, 2020

ORS and Intervenor Testimony due December 7, 2020

Rebuttal Testimony due December 21, 2020

Surrebuttal Testimony due January 4, 2021

Joint DEC/DEP Evidentiary Hearing Beginning Date: January 20, 2021 (hearing shall continue each day thereafter until completed)

Briefs and Proposed Orders due February 5, 2021

PSCSC Final Orders issued March 3, 2021

Compliance Tariffs due March 15, 2021
